

<ul> <li>Mild withdrawal</li> <li>Mild out of character behavior</li> <li>Reports sadness</li> <li>Head Down</li> <li>Reports a mild conflict (peer, family, teacher)</li> <li>Teary eyed</li> <li>Distracted</li> <li>Lack of motivation/apathy</li> </ul>	<ul> <li>Withdrawal</li> <li>Out of character behavior for multiple days</li> <li>Sadness</li> <li>Head Down for multiple days</li> <li>Reports a conflict (peer, family, teacher)</li> <li>Crying</li> <li>Distracted for multiple days</li> <li>Lack of motivation/apathy for multiple days</li> </ul>	<ul> <li>Extreme withdrawal</li> <li>Angry outbursts that can be aggressive verbally/physically</li> <li>Extreme Sadness/Crying</li> <li>Significant conflict where impending threat of harm is present</li> <li>Anxious behaviors (hyperventilating, hiding, running away, panic attack)</li> <li>Extremely disruptive to the learning environment</li> </ul>	<ul> <li>Threatening to kill himself/herself</li> <li>Seeking lethal means</li> <li>Talking/Writing/Artwork about suicide.</li> <li>Dramatic mood change</li> <li>Withdrawal from Friends/Family/Society</li> <li>Giving Away Possessions</li> <li>Acting recklessly</li> <li>Increasing Alcohol/Drug use</li> <li>Neglect of Personal Appearance</li> <li>Personality Change</li> <li>Anxiety, Agitation, Anger</li> <li>Sadness, Crying</li> </ul>

<ul> <li>Contact the counselor via email. Subject Line: Low Risk. Response time within 48 hours.</li> <li>Student may complete: "Request to See Your Counselor" Form to be seen within 48 hours.</li> <li>If it is a bullying issue, students may report bullying via an anonymous form at CMS or through the district website.</li> <li>Staff may refer for short term interventions using the "small group counseling" google referral form provided 2 times a year.</li> </ul>	<ul> <li>Contact the counselor via email or phone. Subject Line: Medium Risk. Response time within 24 hours.</li> <li>Staff may send the student to the counseling office on pass to be seen within the school day.</li> <li>Staff may refer for short term interventions using the "small group counseling" Google referral form provided 2 times a year.</li> </ul>	<ul> <li>Contact the office and/or counselor via phone. Response time ASAP.</li> <li>Staff may complete: "RED Alert" form for students to be seen immediately.</li> </ul>	<ul> <li>Follow: Be A Link! Protocol</li> <li>Response time is immediate</li> </ul>
